# **2018 Central U.P. Rally**

## **SUPPLEMENTARY REGULATIONS**

### **1. Description**

- 1.1. *Central U.P. Rally* (also referred as CUP Rally) will take place on the roads of Menominee Co., Michigan on June 16, 2018.
- 1.2. Rally Headquarters will be at North Central Jr/Sr High School, 3795 US-2 & 41, Powers, MI, 49874, Saturday June 16th. (see Appendix 2 for applicable map).
- 1.3. *Central U.P. Rally* will start and end near Powers, MI.
- 1.4. There will be a Parc Exposé at the start of the rally, June 16, 2018. The location is Veteran's Park in Powers, Michigan. Location map is located in the route book and Appendix 2 of this document. Instructions for parking will be given by marshals. Drivers, Co-drivers are encouraged to remain near their vehicles to interact with the public. Open servicing in Parc Exposé will be permitted.
- 1.5. Scheduled service will take place in a single location for the duration of the rally.
- 1.6. All stages on *Central U.P. Rally* are on unpaved surfaces. The competitor can expect roads conditions to be varied from hard packed gravel to soft sand.

### 3. Entries

- 3.1. Entries open at 12:00 AM on April 2nd, 2018, and close at the end of registration on June 16th, 2018.
- 3.2. CUPR is for cars meeting the NASA Rally rules only.
- 3.3. Entry must be made online at [my.nasarallysport.com](http://my.nasarallysport.com).
- 3.4. Entries will only be secured with payment in full.
- 3.5. All entry periods, will end at 6PM EST, on the entry close date.
- 3.6. 2018 Entry Fees are as follows (payment must be received for entry to be valid):

Jemba Course notes are included in the total entry cost when paying online

- 3.7. Pre-event payment will be accepted using on-line payment on the NASA web site only.
- 3.8. Early Entry fee will only be available to those who have registered and **paid** before the Regular Entry period begins. The Regular Entry fee will only be available to those who have registered and **paid** before the Late Entry period begins. Submitting your online Entry Form early, without payment will not satisfy the entry period requirements. Entry fee schedule will be determined upon date of payment.
- 3.9. Entry fees shall be refunded in full, if the event is canceled by the organizer.
- 3.10. Entry fees shall be refunded in full, if the organizer refuses the entry.
- 3.11. There will be no entry refund, after the competitor leaves the first time control.
- 3.12. When the competitor withdraws, prior to the event, the refund amount will depend on when the entrant withdraws and when they paid their entry. See the table below.

- 3.13. For an entry to be considered complete, the following must be submitted

3.13.1. The entire entry fee

3.13.2. All driver information – online form

- 3.13.3. All navigator information – online form
- 3.13.4. All rally vehicle information (as needed) – online form
- 3.13.5. All service crew information (as needed) – online form
- 3.13.6. All service vehicle information (as needed) – online form
- 3.14. All racers, without exception, must have a current medical form, signed by a doctor, on file with NASA Rally Sport.
- 3.15. A maximum total of 30 vehicles, will be accepted. If entries exceed 30 vehicles, a “waiting list” will be tracked and entry will be granted based on date of paid entry, should entry openings become available.
- 3.16. The organizers reserve the right to cancel the event if insufficient entries are received.
- 3.17. The organizers reserve the right to cancel the event if road conditions do not allow safe and efficient travel over the stage roads.
- 3.18. Members of the Central U.P. Rally organizer committee may participate in the event, as competitors, without penalty. Anyone who feels this is an unfair advantage, is invited to join the organizer committee and take on some of the many needed tasks to make the Central U.P. Rally a success.

## 4. Eligible Classes

- 4.1. For Central U.P. Rally, the following car classes will be scored. Additional car classes may be added to meet entries received.

## 5. Fuel

- 5.1. No fuel arrangements have been made. Competition teams are responsible for acquiring their own fuel sources. Premium (93 Octane) fuel is available in the Powers area.

## 6. Testing

- 6.1. No testing is allowed, within Menominee County, with definitions and penalties as per the GRRs.

## 7. Reconnaissance & Course Notes

- 7.1. The 2018 Central U.P. Rally **will not** provide reconnaissance of the rally stages.
- 7.2. Jemba course notes, created by P-Sport, will be the only allowable course notes for Central UP Rally.

### 8. Identification Numbers

- 8.1. Non-NASA number backer identifications must either be removed or covered.
- 8.2. The size and location, of the space for vehicle numbers, is governed by the championship regulations.
- 8.3. Car numbering will be per section 6.4 of the Atlantic Rally Cup regulations. The size and location of the space for vehicle numbers is governed by the championship regulations.

### 9. Registration

- 9.1. On site competitor registration will be located at North Central Jr/Sr High School, 3795 US-2 & 41, Powers, MI 49874 (see map Appendix 2).
- 9.2. Registration will be per schedule in Appendix 1.
- 9.3. Documents to be checked
  - 9.3.1. Online entry with all required information completed
  - 9.3.2. Driver and navigator NASA membership cards (if not prechecked online).
  - 9.3.3. Driver and navigator rally competition license cards (if not prechecked online).
  - 9.3.4. Driver and navigator state issued driving license cards (if not prechecked online).
- 9.4. The Official Notice Board will be at Registration during the open registration hours, the Start and Service areas during competition and at the Finish in Powers, MI.

### 10. Scrutineering

- 10.1. Scrutineering will be held at North Central Jr/Sr High School, 3795 US-2, Powers, MI (see map Appendix 2).
- 10.2. Scrutineering will be per schedule in Appendix 1.
- 10.3. Scrutineers will check the safety and eligibility of the competition vehicle. The driver, navigator do not need to be present at Scrutineering; however all required safety gear must be examined at the same time the vehicle is examined.
- 10.4. Vehicle log books may be retained, by the Chief Scrutineer. They shall be picked up at the conclusion of event awards at Veterans Park. The Chief Scrutineer will be made aware of any DNF's and those vehicles may be inspected prior to the log book being returned. It is the competitor's responsibility to obtain their log book. Any uncollected log books, may be mailed, at the competitor's expense, by contacting the Chief Scrutineer.

### 11. Practice Stage

- 11.1. There will be no prepared practice / shake down stage.

### 12. Start of the Rally

- 12.1. The review for start order, if required, will take place at 9:00 PM on Friday June 15th, at location TBD.
- 12.2. The starting list will be posted as soon as possible after the close of registration. The list will be posted on the Official Notice Board no later than 12:00 PM on Saturday June 16, 2018.
- 12.3. The official start, of the rally, will take place from Veterans Park at the time specified in Appendix 1.

### 13. Running of the Rally

- 13.1. Central UP Rally will be run in Central Time Zone
- 13.2. All time card exchanges are specified in the Route Book.
- 13.3. If a control issues a time that the competitor believes to be in error, the competitor will point out the problem to the control worker and request a correction. If the dispute cannot be solved immediately, the worker will, on request, initial the time and note the nature of the dispute in the Control Log. The competitor will then submit a written scoring inquiry to scoring.
- 13.4. All rally officials and their delegates are Judges of Fact. Their observations constitute valid testimony, and they are authorized to report violations of these rules and the NASA Rally Sport rules to the Stewards.
- 13.5. Any circumstances not covered by these Supplementary Regulations and the NASA Rally Sport Rules shall be decided by the Chairman, Clerk of Course, or the Stewards, as applicable.
- 13.6. Cars will be released on one minute intervals.
- 13.7. Any crew retiring permanently, from the rally, must report such retirement to the Clerk of the Course, and/or stage time control, as soon as possible using the Withdrawl Form located at the back of the road book.
- 13.8. Reseed will be following completion of Section 1, of the rally.
- 13.9. Radio repeater frequencies for CUPR. Competitors may not broadcast into Net Control, with the exception of emergency traffic.
  - 13.9.1. Dickinson County: 146.850- tone: 100 hz
  - 13.9.2. CUP Rally Repeater: 146.775- tone: tbd
  - 13.9.3. Simplex Backup : 146.500

### 14. Re-Starting

- 14.1. As the rally is contained within a single leg, there are very limited opportunities for returning a vehicle to the field. The only point at which any reentry will be considered is at the single service for the rally. Teams that DNF the rally, during the first section, may request to be re-started at the beginning of service, for "seat time" purposes only. 2018 Central U.P. Rally will not utilize any form of "Super Rally". Re-Starting will be at the discession of the Clerk-Of-Course and/or Chairman for safety and schedule considerations. But all effort will be made to accommodate the request to re-start at the earliest opportunity. The vehicle will be scored as Did Not Finish (DNF). The vehicle will no longer be a competitor.

- 14.2. Competitors, re-starting, will be re-inserted relatively close to their previous road position. Teams re-starting must not pass or interfere with any other competitor (excluding disabled or stopped vehicle)

### **15. Service**

- 15.1. Service location will be Veteran's Park. Surface will be a mix of gravel and tarmac, depending on service location. Service location will not move during the rally.
- 15.2. The Central U.P. Rally schedule and route will be favorable to the option of "self service".
- 15.3. As the Service area is limited, teams will be limited to one (1) service vehicle per competitor, and must fit within the assigned service spot. Regular service space will be 15' wide x 40' long.
- 15.4. Each service vehicle and its personnel must be registered. All service crew participants, including minors, must sign a waiver at Registration. Proof of insurance for all service vehicles must be submitted on-line in advance.
- 15.5. 2018 Central U.P. Rally will not utilize a designated "Fueling Zone". Teams are allowed, to refuel, in their service areas. All fueling safety procedures must be adhered to. Recommended that teams utilize a "catch pan" or container under the fueling location, to contain any potential spills.
- 15.6. Servicing from trailers will be allowed only after approval from Chief of Service.
- 15.7. Teams requiring oversize service areas (Trailers, Large Rigs), must notify the event, at a minimum of 14 days prior to the event. Notification after that deadline may result in teams not obtaining their desired service requirements.
- 15.8. Only official, competing and registered service vehicles are allowed entry into the service area. There will be ample parking for any non-registered vehicles, near the service area.
- 15.9. Service crews must use a tarp under competing vehicles at all times while they are being serviced. These tarps must extend beyond the vehicle in all directions.
- 15.10. Transport only trailers may not be parked in service areas. Trailers used for servicing are exempted. Transport trailer parking will be available near the service area for the duration of the event.

### **16. Impound and Post Event Inspection**

- 16.1. All finishing vehicles may be directed to impound / Parc Expos'e at the final Main Time Control. The vehicles are required to remain in the Impound area until released by the Event Steward or his designee, or referred for additional inspection as directed.
- 16.2. Selected vehicles may be subject to tear-down at a time and place to be announced.

### **17. Novice Competitor Orientation**

- 17.1. Competitors must attend the Novice Competitor Orientation until they have completed three orientations and/or met requirements as listed in the NRS rules.
- 17.2. The Novice Competitor Orientation (NCO) will be held at Veteran's Memorial Park pavillion. Check the official notice board, for time. New competitors are encouraged to participate in registration on Friday night to accommodate the training schedule. The Novice Competitor Orientation cost is five dollars per attendee, payable to the instructor, to cover material.

Competitors who are not required to attend, but wish to observe, are welcome to do so at no charge.

- 17.3. Participation will be in accordance with GRR 2.5.9: New rally competitors are required to participate in a Novice Competitor Orientation (NCO) and It is the competitors obligation to see that this requirement is satisfied. Competitors who are required to attend and who fail to do so will not be allowed to start the rally

Competitors wishing an exemption from the NCO may request an exemption by documenting relevant rally experience on an NCO Exemption Request Form, available from Anders Green, (anders@nasarallysport.com, 919.697.5282) , and submitted to Anders Green for approval 14 days prior to close of registration.

- 17.4. Competitors purchasing a NASA Rally Sport rally license, for the first time, must attend the NCO unless granted an exemption by the event Steward.

### **18. Results**

- 18.1. Results will be posted in accordance with NASA Rally Sport rules.
- 18.2. Event trophies will be awarded to the 1<sup>st</sup> place finisher in each scored class
- 18.3. ARC trophies to be awarded to places per the ARC rules.

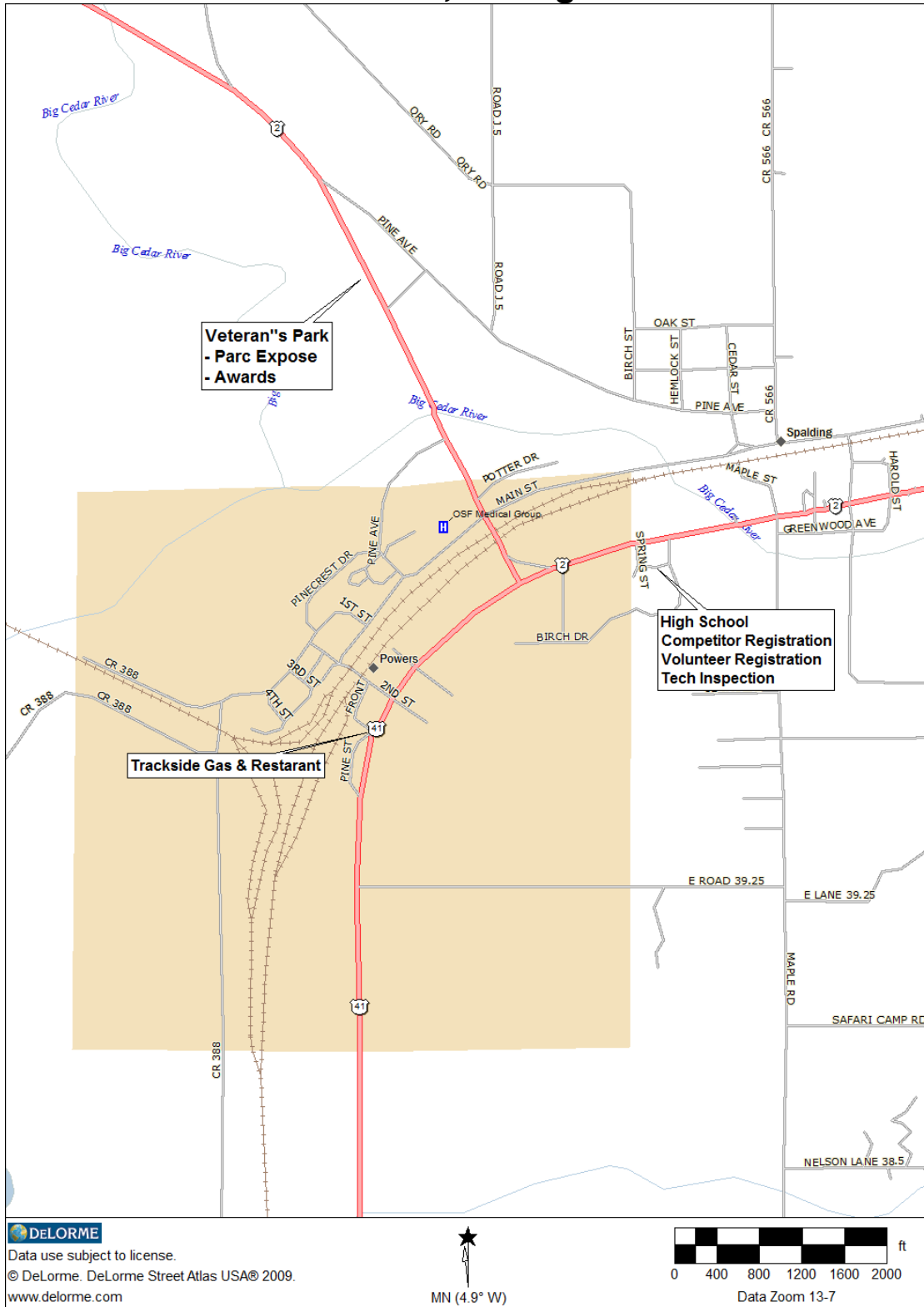

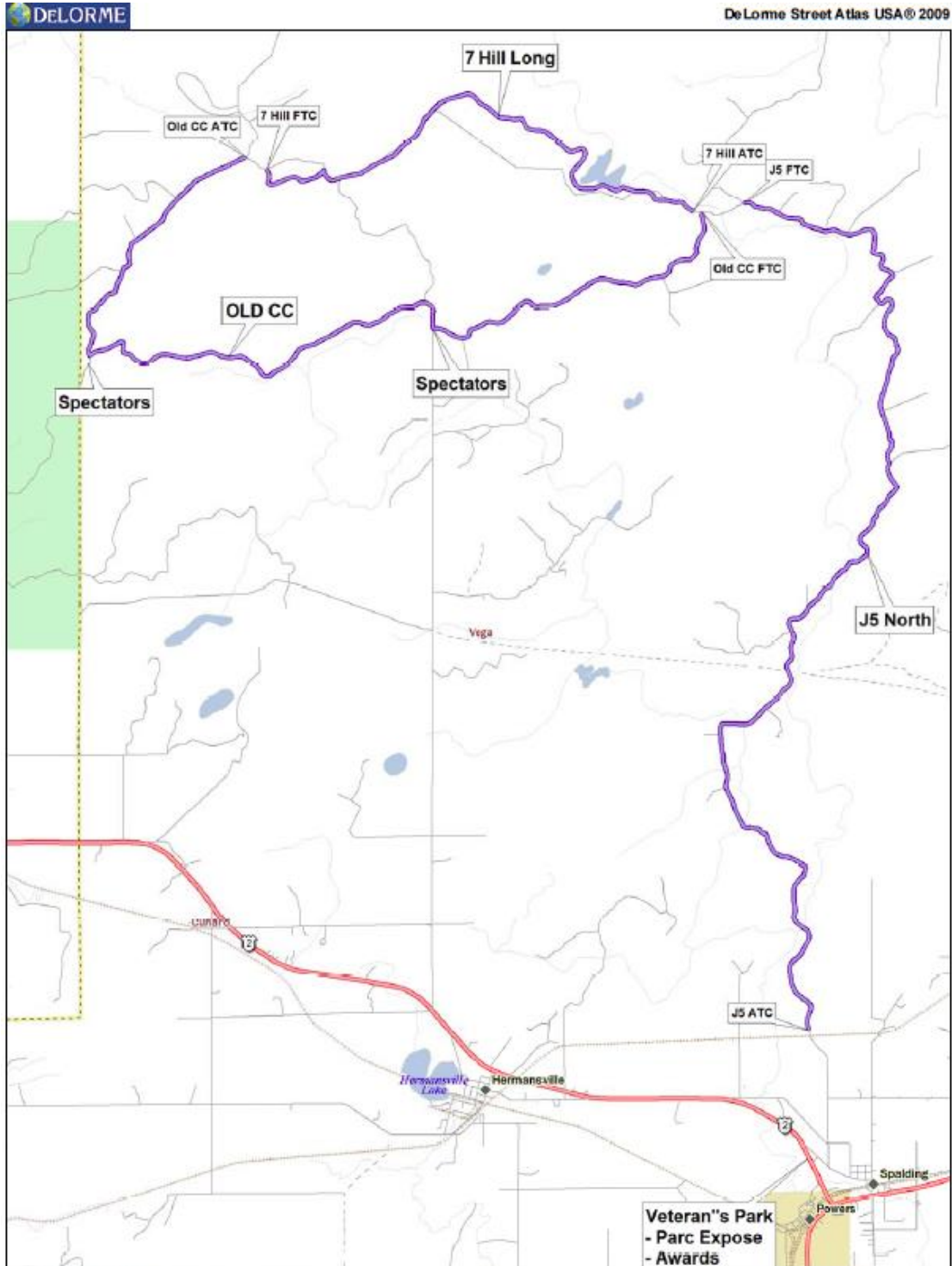
